

## House regulations for the TT Circuit Assen

Welcome to the Assen TT Circuit.

To ensure a pleasant and safe stay please take note of the following points.

### General rules of behaviour

- During all events at the TT Circuit Assen the instructions, prescriptions and regulations of the sporting federations, under which auspices the events are organised, are also applicable but only as far as these are not conflicting with rental terms of conditions, the general terms of conditions and other regulations of the circuit
- The Regulation Traffic codes and signs (RVV) are applicable on the circuit;
- It is not permitted to ride scooters, bikes, motorbikes or to drive cars over the slopes around the circuit;
- Tickets must be shown on request;
- Permanent pass holders must wear passes where visible;
- Directions given by employees and officials must be obeyed at all times;
- Unauthorised persons are not allowed on the track or in the pit lane during training or races;
- Vehicles must be parked in the allocated or indicated areas;
- No parking in the "Parc-Ferme";
- No noise hindrance after 18.00;
- Motorised vehicles are not allowed on the track after 18.00 hrs. or before 9.00 hrs

### Calamities

- In case of a calamity extinguish materials are available under the office building at the paddock side;
- In case of a calamity there is an AED available left to Pit box 1.
- If necessary the national alarm number **112** can be called in case of a calamity.

### Paddock regulations

- The maximum speed in the paddock is 15 km/h;
- Persons under 12 years may not drive motorised vehicles;
- Through roads, water hydrants and energy facilities must be accessible at all times;
- The entrance to the "Parc-Ferme" must be kept clear at all times;
- No parking behind the white lines near the pit boxes and the circuit's offices;
- Pets are not allowed in the paddock;

- Burn-outs, donuts etc. may not be performed in the paddock;
- Extra junction boxes may not be used when using the electrical facilities;
- No smoking in the vicinity of the petrol station or in the working area (the area in the paddock where the pit boxes are situated);
- The prescriptions mentioned in the User-Regulations of the Fire Brigade are applicable during the stay at the circuit;

### Pit box regulations

- We refer you to the regulations list which can be found in all pit boxes.
- Children under 16 years will, in all cases, be denied entry to the pit lane;

### Milieu and hygiene regulations

- Vehicles undergoing maintenance must have a milieu mat;
- Used oil must be disposed of in the allocated oil drums;
- Tyres and batteries may not be left in the enclosure;
- Please dispose of all garbage in the allocated garbage containers;
- Showers and toilets must be left clean and as you would wish to find them;

Relevant prescriptions and regulations are available for inspection in Riders Info.

In case you don't obey the rules as mentioned above the TT Circuit Assen (meaning the Foundation Circuit of Assen and/or the companies linked to this foundation) is empowered by means of guards/security staff to take appropriate action against offenders, including the immediate removal from the circuit and its boundaries, paddock and/or pit of persons and/or goods.

**The management is not liable for damage to persons or goods, occurred during the stay at the TT Circuit Assen. In case one or more prescriptions set out above are not respected the TT Circuit Assen is entitled to withhold any possibly paid in deposits in full or partly (up to the Foundation's choice) by way of a fine, without detracting anything from the right of the Foundation to claim the damage sustained from the lessee.**
